McAfee Software End User License Agreement

NOTICE TO ALL USERS: CAREFULLY READ THE FOLLOWING LEGAL AGREEMENT ("AGREEMENT"), FOR THE LICENSE OF SPECIFIED SOFTWARE ("SOFTWARE") BY NETWORK ASSOCIATES, INC. ("McAfee"). BY CLICKING THE ACCEPT BUTTON OR INSTALLING THE SOFTWARE, YOU (EITHER AN INDIVIDUAL OR A SINGLE ENTITY) CONSENT TO BE BOUND BY AND BECOME A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE BUTTON THAT INDICATES THAT YOU DO NOT ACCEPT THE TERMS OF THIS AGREEMENT AND DO NOT INSTALL THE SOFTWARE. (IF APPLICABLE, YOU MAY RETURN THE PRODUCT TO THE PLACE OF PURCHASE FOR A FULL REFUND.)

1. License Grant. Subject to the payment of the applicable license fees, and subject to the terms and conditions of this Agreement, McAfee hereby grants to you a non-exclusive, non-transferable right to use one copy of the specified version of the Software and the accompanying documentation (the "Documentation"). You may install one copy of the Software on one computer, workstation, personal digital assistant, pager, "smart phone" or other electronic device for which the Software was designed (each, a "Client Device"). If the Software is licensed as a suite or bundle with more than one specified Software product, this license applies to all such specified Software products, subject to any restrictions or usage terms specified on the applicable price list or product packaging that apply to any of such Software products individually.

a. <u>Use</u>. The Software is licensed as a single product; it may not be used on more than one Client Device or by more than one user at a time, except as set forth in this Section 1. The Software is "in use" on a Client Device when it is loaded into the temporary memory (i.e., random-access memory or RAM) or installed into the permanent memory (e.g., hard disk, CD-ROM, or other storage device) of that Client Device. This license authorizes you to make one copy of the Software solely for backup or archival purposes, provided that the copy you make contains all of the Software's proprietary notices.

b. Server-Mode. You may use the Software on a Client Device as a server ("Server") within a multi-user or networked environment ("Server-Mode") only if such use is permitted in the applicable price list or product packaging for the Software. A separate license is required for each Client Device or "seat" that may connect to the Server at any time, regardless of whether such licensed Client Devices or seats are concurrently connected to, accessing or using the Software. Use of software or hardware that reduces the number of Client Devices or seats directly accessing or utilizing the Software (e.g., "multiplexing" or "pooling" software or hardware) does not reduce the number of licenses required (i.e., the required number of licenses would equal the number of distinct inputs to the multiplexing or pooling software or hardware "front end"). If the number of Client Devices or seats that can connect to the Software can exceed the number of licenses you have obtained, then you must have a reasonable mechanism in place to ensure that your use of the Software does not exceed the use limits specified for the licenses you have obtained. This license authorizes you to make or download one copy of the Documentation for each Client Device or seat that is licensed, provided that each such copy contains all of the Documentation's proprietary notices.

c. <u>Volume Licenses</u>. If the Software is licensed with volume license terms specified in the applicable price list or product packaging for the Software, you may make, use and install as many additional copies of the Software on the number of Client Devices as the volume license authorizes. You must have a reasonable mechanism in place to ensure that the number of Client Devices on which the Software has been installed does not exceed the number of licenses you have obtained. This license authorizes you to make or download one copy of the Documentation for each additional copy authorized by the volume license, provided that each such copy contains all of the Documentation's proprietary notices.

- 2. Term. This Agreement is effective for an unlimited duration unless and until earlier terminated as set forth herein. This Agreement will terminate automatically if you fail to comply with any of the limitations or other requirements described herein. Upon any termination or expiration of this Agreement, you must destroy all copies of the Software and the Documentation. You may terminate this Agreement at any point by destroying all copies of the Software and the Documentation.
- **3. Updates**. For the time period specified in the applicable price list or product packaging for the Software you are entitled to download revisions or updates to the Software when and as McAfee publishes them via its electronic bulletin board system, website or through other online services. For a period of ninety (90) days from the date of the original purchase of the Software, you are entitled to download one (1) revision or upgrade to the Software when and as McAfee publishes it via its electronic bulletin board system, website or through other online services. After the specified time period, you have no further rights to receive any revisions or upgrades without purchase of a new license or annual upgrade plan to the Software.
- 4. **Ownership Rights.** The Software is protected by United States copyright laws and international treaty provisions. McAfee and its suppliers own and retain all right, title and interest in and to the Software, including all copyrights, patents, trade secret rights, trademarks and other intellectual property rights therein. Your possession, installation, or use of the Software does not transfer to you any title to the intellectual property in the Software, and you will not acquire any rights to the Software except as expressly set forth in this Agreement. All copies of the Software and Documentation made hereunder must contain the same proprietary notices that appear on and in the Software and Documentation.
- 5. Restrictions. You may not rent, lease, loan or resell the Software. You may not permit third parties to benefit from the use or functionality of the Software via a timesharing, service bureau or other arrangement, except to the extent such use is specified in the applicable list price or product packaging for the Software. You may not transfer any of the rights granted to you under this Agreement. You may not reverse engineer, decompile, or disassemble the Software, except to the extent the foregoing restriction is expressly prohibited by applicable law. You may not modify, or create derivative works based upon, the Software in whole or in part. You may not copy the Software or Documentation except as expressly permitted in Section 1 above. You may not remove any proprietary notices or labels on the Software. All rights not expressly set forth hereunder are reserved by McAfee. McAfee reserves the right to periodically conduct audits upon advance written notice to verify compliance with the terms of this Agreement.

6. Warranty and Disclaimer.

a. <u>Limited Warranty</u>. McAfee warrants that for sixty (60) days from the date of original purchase the media (e.g., diskettes) on which the Software is contained will be free from defects in materials and workmanship.

- a. <u>Customer Remedies</u>. McAfee's and its suppliers' entire liability and your exclusive remedy for any breach of the foregoing warranty shall be, at McAfee's option, either (i) return of the purchase price paid for the license, if any, or (ii) replacement of the defective media in which the Software is contained. You must return the defective media to McAfee at your expense with a copy of your receipt. This limited warranty is void if the defect has resulted from accident, abuse, or misapplication. Any replacement media will be warranted for the remainder of the original warranty period. Outside the United States, this remedy is not available to the extent McAfee is subject to restrictions under United States export control laws and regulations.
- a. Warranty Disclaimer. Except for the limited warranty set forth herein, THE SOFTWARE IS PROVIDED "AS IS." TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, MCAFEE DISCLAIMS ALL. - **9. Export Controls**. Neither the Software nor the Documentation and underlying information or technology may be downloaded or otherwise exported or re-exported (i) into (or to a national or resident of) Cuba, Iran, Iraq, Libya, North Korea, Sudan, Syria or any other country to which the United States has embargoed goods; or (ii) to anyone on the United States Treasury Department's list of Specially Designated Nations or the United States Commerce Department's Table of Denial Orders. Welcome to Oil Change

When you buy new software, you may assume that it is the latest available. However, one of the not-so-hidden secrets of the computer industry is that manufacturers often continue to make improvements—called "updates" long after a product is officially "released." Manufacturers typically slip updates into production without fanfare.

While manufacturers charge for "upgrades," which are substantial modifications to the program, they usually make updates available for free or at cost. The catch is that you have to know that updates exist and how to get them.

Before Oil Change[™], you had two options for getting updates:

- If you had a problem, you could call the manufacturer's technical support center.
- Or, if you had a great deal of time, you could rummage through manufacturers' Web sites in search of the elusive update.

Oil Change, a subscription service, offers a third, better option. It can:

- Scan for software and hardware products on your computer, then download updates directly from the Web sites of software and hardware manufacturers.
- Install many of the updates automatically, and reverse updates if you aren't satisfied.
- Scan while you're away from your computer and notify you when it finds updates.

How Oil Change works

McAfee Software constantly gathers information about software updates—including their locations on manufacturers' Web sites—and stores this information on the ActiveHelp[™] server.

When Oil Change scans your computer, it is really making a list of hardware and software products that it recognizes. Then Oil Change uses your Internet connection to contact the ActiveHelp server—which works like a giant card catalog in a library— to retrieve update information relevant to the products on your computer. Oil Change even works even while you're doing something else, or are away from your computer. When Oil Change completes its check, it displays the products and update information in the Supported Applications and Drivers dialog box as shown in figure 1-3 on page 7.

If you are concerned about security, you may rest assured that Oil Change will not in any way compromise your privacy. Oil Change is non-intrusive and keeps the sensitive data on your computer private:

- The list of hardware and software products Oil Change creates never leaves your computer.
- The McAfee Software ActiveHelp server is a secure database that only Oil Change can access.
- Whether you get an update now, or get it later, your computer connects directly to the Web site of the original product's manufacturer to download the update to your computer.
- If you're unhappy with the installed updates, you can use Undo to restore your computer to the settings it had before you installed the update.
- McAfee Software scans the updates for viruses and warns you if the update has changed since it was certified by McAfee Software.

Although Oil Change updates are virus-free, you should always use anti-virus software when connected to the Internet.

System requirements

Before installing Oil Change, make sure your computer meets these requirements:

- Windows 95 or Windows 98 operating system
- IBM PC or compatible computer with 80386 or higher processor
- 8 megabytes (MB) minimum of RAM
- 6 MB of free hard disk space for installation (you may need more space to install the updates)
- Microsoft mouse or compatible pointing device

To use Oil Change, you must have one of the following types of Internet connections:

- Connection through a network
- Some networks have an Internet connection that you can use by connecting to the network—either directly or through Dial-Up Networking.

• Connection through an Internet Service Provider (ISP)

If you connect to the Internet through an ISP, your computer must have a modem installed.

An ISP acts as the middle man between you and the Internet. Your computer connects (using your modem) to the ISP's equipment, which in turn connects to the Internet.

Well-known ISPs include:

- America Online, CompuServe, or Netcom in the U.S.
- T-Online and CompuServe in Germany
- NiftyServe and PC-VAN in Japan
- BT Internet and UUNET UK in the United Kingdom.
- In addition, you must also have an:
- Internet Browser

A browser is software that lets you view text and graphics and download files from Web sites. Oil Change can use most browsers including Netscape Navigator 2.0 and higher and Microsoft Internet Explorer 2.0 and higher.

Oil Change supports these versions of America Online and CompuServe: America Online for Windows 95 3.0 and higher; and CompuServe Interactive 3.0 and higher.

Installing Oil Change

To avoid most installation problems, close all open programs—including those that run in the background, like screen savers, before installing Oil Change.

To install Oil Change

1. Insert the Oil Change CD in the CD-ROM drive.

The Oil Change Setup screen appears.

If installation doesn't start automatically, click Start on the Windows taskbar, click Run, then type d:\setup. If d: is not the drive letter of your CD-ROM drive, substitute the letter of the drive.

2. Click Install Oil Change.

- 3. Read the information in the Welcome dialog box and click Next.
- 4. Read the Software License Agreement and click Yes.
- 5. In the Choose Destination Location dialog box, click Next to accept the default location for Oil Change installation: C:\Program Files\Oil Change. Or, use Browse to navigate to a different location.
- 6. In the Choose Connectivity Options dialog box, select one of the following:
 - Auto Detect to have Oil Change identify the type of Internet connection you are using. Oil Change asks you to start your browser so that it can detect how the browser connects to the Internet. After you are connected, you may need to minimize your browser to continue.
 - Or, click Modify and select:

Direct connection if you are using Oil Change in an office network environment that has a direct connection to the Internet.

Try Connect through a proxy server if Direct connection doesn't work. Some networks route Internet connection requests through a designated or "proxy" server in order to control access to various parts of the Internet. This type of arrangement is referred to as a "firewall." Your network administrator can provide the correct proxy server settings.

Dial-up (Modem) and choose your ISP from the list. If you are using an international version of Oil Change, you may have to enter you international ISP information manually.

Some other type or I don't know the type if you aren't sure how you connect to the Internet and choose not to use Auto Detect.

7. After selecting an Internet connection type, click OK.

The Registration Wizard appears. You must register with McAfee Software before you can use Oil Change. You can do it now or when you start Oil Change for the first time.

- 8. Click Next to continue.
- 9. Follow the Registration Wizard instructions to finish registering.
- 10. Oil Change prompts you to restart your computer. You must restart your computer before you run Oil Change for the first time.

Getting to know Oil Change

Most Oil Change features are accessible from the main window as seen in Figure 1-1.



Figure 1-1. Oil Change main window

These features include:

- Start: Begins searching for updates.
- Help: Displays the online help in Windows help format.
- Exit: Closes Oil Change. If you have any scans or downloads scheduled, Oil Change places an icon in the system tray as reminder.
- Home: Starts your browser and displays the Oil Change home page on the McAfee Software Web site.
- History: Displays the update and undo actions you've performed with Oil Change.
- Undo: Restores your software to its original state before Oil Change installed (automatically) the last update or updates.
- Options: The following options give you control over how Oil Change works.
 - User Profile lets you change your personal information.
 - Cleanup lets you delete assorted types of files when you no longer need them.
 - Connection lets you change how you connect to the Internet.
 - Scan lets you specify when Oil Change checks your computer for new software and hardware products.
 - Undo lets you tell Oil Change to monitor the installation of an update and gather all the information necessary to reverse the process.

- Oil Change Support: Takes you to the McAfee Software Support Web site.
- Less: As seen in Figure 1-1, lets you hide the features that appear at the bottom of the window. Use More, as seen in Figure 1-2, to display them again.

Downloading your first update

After installing and registering Oil Change, you can retrieve your first update. Oil Change should connect automatically to the Internet. If it does not, you should dial your ISP and minimize the browser before starting Oil Change.

To download an update

- 1. Double-click the Oil Change icon on your desktop, and on the main Oil Change window, click Start. Oil Change scans your computer identifying hardware and software products, then searches the ActiveHelp server for update information which is displayed in the Supported Applications and Drivers dialog box, shown in Figure 1-3.
- 2. Select an update. A description of the update appears in the box below the list, and Install is available.

3. Click Install to download the update and display available installation options. See "Getting an update" on page 12 for detailed information about other ways to retrieve updates.

Installing updates automatically or manually

When Oil Change supports an update's installation procedure, you may choose the Auto Install or Manual Install button in the Install dialog box. When you choose Auto Install, we recommend that you leave the Monitor install process... check box in the Install dialog box selected so that Oil Change will be able to undo the update if it doesn't perform as you expect it to. For more information, see "Undoing an update" on page 8.

When an update's installation procedure is not supported, Auto Install is not available, and you must choose Manual Install. You can configure Oil Change to save manual install updates in a specific folder on your hard drive.

Most software manufacturers compress their updates so that they transfer faster. Many updates are packaged into a single program file (.exe extension) that you decompress by double-clicking the file in Windows Explorer.

If an update file doesn't decompress automatically, you must decompress it manually with a program such as WinZip® before you can install it.

Usually, the manufacturer puts installation instructions in a text file (.txt extension) called Readme.txt. If you don't find a Readme file, check other files that have .txt or .doc extensions for installation instructions.

See the online help for specific instructions on installing updates.

Undoing an update

After Oil Change installs an update, you should run the updated product and try it out. If you find that an update does not perform as you think it should, you can use Undo to reverse one or more updates that Oil Change installed automatically. Undo cannot be used to reverse manually installed updates.

To effectively use Undo, you should keep in mind the following:

- It is always a good idea to test a new product update after installation. Multiple changes to your computer can make it hard to determine which update caused the problem.
- Use Undo soon after Oil Change installs the update.

Oil Change saves a backup copy of the original software and system settings that were modified on your hard drive. As you use your computer, system settings change constantly and the backup copy can quickly become outdated.

TIP: You can specify a folder for Oil Change to use to store the backup files. Click Options on the main Oil Change window, then select the Undo tab.

Although Oil Change can undo multiple updates, it can only undo the last update for each product. For example, if you have Oil Change automatically install Microsoft Word and Quicken updates, Oil Change can undo both of these updates.

However, if Oil Change automatically installs two Microsoft Word updates, Oil Change can undo only the last update. To minimize the disk space used by the Undo feature, Oil Change saves one set of backup files per product, such as one set for Microsoft Word, and another set for Quicken.

When you no longer need the backup files, you can delete them from the Undo folder on your hard drive. See the Undo tab in Options. The default location for these files is:

C:\Program Files\Oil Change\Undo

You can also specify a time interval on the Undo tab after which Oil Change deletes backup files automatically. For example, if you enter 7, Oil Change deletes files after they have been on your disk for seven days.

If Oil Change did not monitor the installation process successfully, Oil Change will not be able to undo the update even though the update was installed automatically.

To undo an update

- 1. On the main Oil Change window, click Undo.
 - 1. Select an update. A description of the update appears in the Description box.
 - 2. Click Undo to restore your computer to its original settings before the update.

Scheduling a scan

Oil Change must scan your computer to identify products. If you have a large number of them installed, you may want to schedule a scan for a time when you aren't using your computer extensively.

To schedule a scan

- 1. On the Oil Change window, click Options, and select the Scan tab.
- 2. Do the following:
 - Select Enable background scan of local hard drives.
 - Select the time interval in the Frequency list box.
 - Type the time, including A.M. or P.M.

Some countries use the 24-hour system for telling time. If you are using Oil Change in one of those countries, enter the time in 24-hour format (Do not include A.M. or P.M.).

- 3. For Oil Change to connect to the ActiveHelp server to check for updates after a scan, select Automatically connect to... and make sure that the Remember my password check box is selected on the main Oil Change window.
- 4. Click OK.

Leave your computer on and turn off Oil Change for the scan to take place.

Specifying types of notifications

Oil Change can notify you when it finds updates for any of the products that you place in the Add Products to Monitor dialog box.

To specify notification settings

- 1. On the Supported Applications and Drivers dialog box, click Customize, and select the Monitor tab.
- 2. Click Add to display the Add Products to Monitor dialog box.
- 3. Select a product and click OK. The product appears in the Applications box.

To add more than one product quickly, you can use Shift+Click or Ctrl+Click to select them.

TIP: To remove a product from the Applications box, select the product, then click Remove.

- 4. Click Notification. The Monitored Application Actions dialog box appears. This is where you tell Oil Change how to notify you when updates become available for the monitored products.
- 5. Select or clear the check boxes by the following notification options:
 - Display a message
 - Download the update in background but don't install it
 - Flash the Oil Change icon in system tray
 - Play a sound (wav file)

You can choose more than one type of notification, however, you cannot assign a notification to a specific product. Oil Changes alerts you using all the methods that you have chosen when an update becomes available for any of the products in the list.

Working with updates

The buttons on the right side of the Supported Applications and Drivers dialog box (Figure 1-3) let you perform actions on products and updates. Oil Change provides shortcut menus that let you perform some of these actions more quickly.

Using shortcut menus

In the Supported Applications and Drivers dialog box, right-click a product to display a shortcut menu with:

• Add to Monitored List: If you are interested in getting the latest updates for specific products on your computer, this menu selection lets you add these products to a list that Oil Change automatically checks.

When updates become available, Oil Change notifies you. For more information, see "Specifying types of notifications" on page 10.

- Remove from Monitored List: Although this menu selection lets you delete products from the monitored list, the products will still appear in the Supported Applications and Drivers list.
- Hide: This menu selection lets you hide selected products and all the updates listed under the product so that they no longer appear in the Supported Applications and Drivers list.

To display the product and updates again, click Customize on the Supported Applications and Drivers dialog box, and select the Unhide Products tab.

Select a product, then click Show. The product reappears in the Supported Applications and Drivers list.

Right-click an update, to display a shortcut menu with:

- Install: This menu selection lets you download and install the selected update.
- Get now: This menu selection lets you retrieve one or more updates while you work on something else. Oil Change notifies you when the updates have been downloaded successfully and places an icon by the update in the list.
- Get later: This menu selection lets you schedule when Oil Change downloads one or more updates.

For more information, see "Getting an update" on page 12.

- Stop download: This menu selection is available only when Oil Change is downloading an update. Select this to cancel the download.
- Hide: This menu selection lets you hide individual updates so they no longer appear in the Supported Applications and Drivers dialog box.

For more information about the Supported Applications and Drivers dialog box, see the online help.

Getting an update

You can use the following feature buttons on the Supported Applications and Drivers dialog box to control when Oil Change gets and installs updates:

- Install: Oil Change uses your Internet connection to download the selected update immediately. When complete, Oil Change provides installation options.
- Get: You have two choices:

Get now: Oil Change immediately downloads the selected updates in the order that you select them.

Get later: You can choose a date and time for Oil Change to download an update.

Oil Change keeps track of the updates that it downloads and displays an Oil Change icon by each update to indicate that it is ready for installation.

TIP: You can install the downloaded update by selecting it then clicking Install.

To specify a date and time for Oil Change to get an update

- 1. On the Supported Applications and Drivers dialog box, select the update for Oil Change to download.
- 2. Click Get.
- 3. In the Oil Change Download dialog box, select Get later.

The Date and Time become active.

4. Use the spin control on the Date box to select a date, and type the time in the Time box.

Leave your computer on so that Oil Change can download the updates.

Oil Change displays a list of the updates that have been downloaded and are waiting to be installed each time you run Oil Change.

Reinstalling Oil Change

You may need to reinstall Oil Change:

- If you bought the Oil Change CD and have trouble after the initial installation.
- A McAfee Software Support technician directs you to reinstall Oil Change when you call regarding a problem.

To ensure a successful reinstallation, do the following:

- Download the latest version of Oil Change.
- Have your member name and password on hand.

Select Oil Change and use Find Password to request that your password be sent to you.

- Uninstall the existing Oil Change program.
- Delete all the files from your Windows Temp folder after uninstalling Oil Change.
- Disable all the programs running in the background on your computer.

To get help with pre-installation steps, see online help for step-by-step instructions. Read or print those instructions before uninstalling Oil Change.

There are other important things that affect reinstallation that you need to know about.

- Because McAfee Software frequently updates Oil Change, you should download the latest version from the McAfee Software Web site instead of attempting to reinstall from the CD.
- You don't have to register again. When the Registration Wizard appears during installation, select I already have a member name and password check box and enter your original member name and password.
- If you registered during the initial installation using a serial number, you will not need your serial number for any subsequent reinstallations for the duration of your subscription to Oil Change.

To reinstall Oil Change

- 1. In Windows Explorer, go to the folder containing ocsetup.exe and double-click it.
- 2. Follow the installation instructions.
- 3. On the Registration Wizard, select the I already have a member name and password check box.
- 4. On the next window, enter your member name and password.

A final note

This guide provides information that you need to install and get started using Oil Change.

As you are using Oil Change, you can get information about any of the Oil Change features by pressing F1 (or clicking Help on the main Oil Change window) at any time to display the extensive online help system.

Troubleshooting

If you have problems with Oil Change, read this section before calling the Support center. You may find the solution to your problem here.

Table 1 describes some common Internet problems that you may experience when using the Internet. They are not unique to Oil Change.

Table 2 lists some of the error and alert messages you may receive when using Oil Change. These messages are generated by Oil Change and are specific to the way the Oil Change program works.

Problem	Cause and Solution
Cannot connect to McAfee Software or other Web site	People are using all of the available connections to the Web site. Try again later.
	The site may be down for repair. Try again later.
	If you use a modem to connect to the Internet, Oil Change should initiate the dialer. If you have an automatic dialing program that initiates the dialer, try activating the dialer before trying to connect.
	For some Internet service providers (ISPs), for example: American Online or CompuServe, you should start your browser and connect to the Internet before starting Oil Change.
Slow data transfer	The speed of your modem determines, in part, how fast data transfers from the Internet to your computer. ISPs offer connections at various speeds. Try checking the speeds supported by your modem, then check with the ISP for available connections at the highest speed. You may also want to consider upgrading your modem.
	The Internet could be busy. The number of people trying to download data affects the data transfer rate. Try again later.
	Noise on the telephone line can slow down data transfer. Try again later.

Table 1-1. Common problems

When you receive this error	Try this
Scan error	On the main Oil Change window, click More to display additional features.
	Click Options and select the Cleanup tab.
	Click Clear Cache.
Incorrect password	Click Oil Change Support on the main Oil Change window.
	On the Support page, select Oil Change.
	On the Look Up Your Oll Change Password page, type your member name, then click Find My Password.
	McAfee Software finds your password and sends it to the e-mail address you specified in your original registration.
Used serial number	If you are reinstalling Oil Change, and you have already used this serial number to register, you do not have to register again. Your member name is valid for the length of the subscription.
Login failed, cannot obtain authentication from server	The ISP, Network Service Provider (NSP), or one of the Internet nodes in the connection path does not have the ActiveHelp server listed in its directory of server names.
	Solution
	If you receive a "Bad IP address" message, the ISP or NSP cannot locate the ActiveHelp server. You will have to contact them for help.
	If you receive, a "The request has timed out," the ISP or NSP can resolve the name, but the ActiveHelp server is temporarily unavailable. Try again later.
No supported products	On the main Oil Change window do the following:
found	Click Options and select Cleanup.
	Click Clear Cache, then click Clear Scan.
