Spreadsheet Summary

This spreadsheet is designed for tracking key values that result from a reasonable number of mutual fund transactions per year. It is recommended that a new worksheet be used for each mutual fund.

Required input data for each transaction are: Type of Transaction (Purchase or Sale), Amount of Transaction and Number of Shares involved.

Resulting outputs from each transaction are: Transaction Price per Share, Total Number of Shares Held, Cost of Currently Held Shares and Average Cost of Currently Held Shares.

Additionally, a 'Sale' transaction will cause an entry in the Schedule D summary page that records the transaction and computes the loss or gain using the **Average Cost basis (single-category method.)** The Schedule D is intended to be used as a worksheet for tax return preparation and not as a form for filing with the IRS.

The worksheet is password protected to prevent alteration of formulas in the shaded areas of the worksheet.
