

PARALLAXIS® BOOST-IT® LICENSE AGREEMENT

This license statement and limited warranty constitutes a legal agreement ("License Agreement") between you (either as an individual or a single entity) and Parallaxis Software Company ("Parallaxis" or "Company") for the software product ("Software") identified above, including any software, media, and accompanying on-line or printed documentation. This copy of Boost-It may either be used by a single person who uses the software personally on one or more computers, or installed on a single workstation used nonsimultaneously by multiple people, but not both. For instance, if 8 different workstations will access Boost-It on the network, each workstation must have its own Boost-It license, regardless of whether they use Boost-It at different times or concurrently.
