

# Soft Trek, Inc. Search Master®

This document contains important information about Search Master. You should read this document before use.

Search Master is a high performance application that allows you to scan any directory for files or text strings within files. It also provides the capability for replacing found text strings with a replacement string. Its major features include:

**File Search.** Search Master will search for files in a specified drive, (local or network drive), and a specified directory, optionally searching all subdirectories under the specified directory. A single file may be searched for or one or more wildcard patterns may be specified. A wildcard is a character that represents any character or group of characters that match the same position in file names. Use the question mark (?) to represent a single character in a specific position. For example: the file pattern ?rchmstr.e?e will find all files that have "rchmstr" in the second through eighth positions and an "e" in the first and last position of the file extension. Use the asterisk (\*) to represent one or more characters. For example: the file pattern srch\*.\* will find all files that begin with "srch" and have any extension.

**Text Search.** Search Master will search for a specified text string in files according to the drive, directory and file pattern specifications described above. Options for text search include:

**Case Sensitive** searches where the text being searched for must match the specified case (e.g. "Search Master" versus "search master").

**Count** records the number of occurrences in each file that the search text is found.

**Text Replacement.** Search Master will search for a specified text string in files according to the drive, directory and file pattern specifications described above. When a file has been found that meets the criteria, the text string can be replaced by the replacement string. There are two modes of replacement: Verify and Replace All. Options for text replacement include those listed under Text Search and the following:

**Whole Word** searches for the text string delimited by a specific set of characters. Search Master uses the following characters as whole word delimiters:

() {} [] < > . , ; = # ! ? | ' " / \ tab, line feed, carriage return, and space.

For example: " *soft* " versus "Microsoft".

The reason that WholeWord is not employed on text search is that processing all the permutations of the delimiter set would degrade text search performance dramatically.

A workaround is to search for a string with a leading delimiting character and/or a trailing delimiting character.

**Calculate Aggregate Directory Size.** Search Master can calculate the aggregate size of a specified directory (i.e. including the correct sizes of all subdirectories within).

**Delete Files.** Search Master can delete specified files that meet the search criteria.

**Printed Report.** Search Master will track the directories and files that meet the search criteria and allow a formatted report to be printed.

**Save Text File.** Search Master will also allow the user to save the search results to disk.

**File Manager Extension.** Search Master can be incorporated into the Windows 3.x File Manager.

## Requirements

Search Master can run under Windows\*, Windows for Workgroups\* and Windows NT\*.

## Installation

SearchMaster is installed by running SETUP.EXE from the File menu in the Windows Program Manager. When running the Search Master installation program, you can decide where to place the files on your system. The default directory is C:\SRCHMSTR.

The user will be prompted for Registration Information: Name, Company and, if you have registered, your Registration Number.

## **DEFINITION OF SHAREWARE**

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.

Search Master is a "shareware program" and is provided at no charge to the user for evaluation. Feel free to share it with your friends, but please do not give it away altered or as part of another system.
