

How to use Desktop Maid

To toggle the desktop icon display between visible and invisible, simply click on the Desktop Maid icon found in the icon tray on the Taskbar. When the icons are visible, Desktop Maid's icon will appear in the tray. A red circle with a slash running through it on top of the Desktop Maid's icon indicates that the icons are hidden. The desktop is considered "clean" when the icons are hidden.

More options are available from Desktop Maid's menu. To access the menu, right mouse click the Desktop Maid icon found in the icon tray on the Taskbar. The menu will appear with the following items to choose from:



Desktop Items

A list of all desktop items. See description below.



Clean Desktop

Select this menu item to toggle the desktop icon display. When a check mark is next to this item, the icons are invisible. If there is no check mark then the icons are visible. This is the default command and has the same effect as clicking (with the left mouse button) on the Desktop Maid icon found in the tray.



Windows Startup

Select this menu item to load Desktop Maid during the Windows startup process. If a check mark is next to the item, Desktop Maid will auto-load during the startup process.



Show Menu Icons

Toggles the menu item icon display. The menu will display faster if the menu icons are turned off.



Help

This will display the Help submenu. Additional information about Desktop Maid, how to register the program, obtaining technical support, and more can be found here.



Exit Desktop Maid

Select this menu item to unload Desktop Maid. Hidden desktop items will be made visible again when Desktop Maid closes.

In addition to the menu items mentioned above, all desktop items will appear as menu items. This allows easy access to the desktop item without having to find the item on the desktop. Selecting a desktop item from the menu has the same effect as double clicking the desktop item itself. The desktop items are available from the menu even if the desktop items are hidden.

Install/Uninstall Desktop Maid

Three installation options are available, based on the download option chosen. One is a self-extracting program, one is a ZIP archive with a setup program, and the third is another ZIP archive with the minimum number of files needed to run Desktop Maid. No setup program is provided for this final option. Follow the steps below for the appropriate option.

Option 1 (self-extracting)

Follow the steps to install Desktop Maid:

- ▶ Run the program **setupdtm.exe**.
- ▶ Follow the Install Wizard instructions as they appear on the screen.

Option 2 (ZIP archive with setup program)

Follow the steps to install Desktop Maid:

- ▶ Unarchive the download file **dtmaid.zip** to a temporary directory.
- ▶ Run the program **Setup.exe**.
- ▶ Follow the Install Wizard instructions as they appear on the screen.

Option 3 (ZIP archive with minimum files)

This option involves installing Desktop Maid manually, therefore it is more complex than the previous options. This option assumes you have strong knowledge of Windows operating system and tools such as Explorer.

Follow the steps to install Desktop Maid:

- ▶ Unarchive the download file **dtm-min.zip** to a directory such as c:\dtm or c:\windows.
- ▶ Run the program **dtmaid.exe**.
- ▶ Follow the instructions below to setup a shortcut in the Startup folder.

At this point, Desktop Maid has been installed. Desktop Maid can be setup to automatically run during the Windows startup. To set this option, run Desktop Maid. The Desktop Maid icon, a computer monitor, will appear in the icon tray found on the Taskbar. Right mouse click this icon and select the **Windows Startup** menu item. This will place a shortcut to Desktop Maid in the Startup folder. Read the section entitled [How to use Desktop Maid](#) for more instructions on using this program.

Uninstalling Desktop Maid

There are two ways to uninstall and remove Desktop Maid, depending on how it was installed. If *Option 1* or *Option 2* was used with the setup program, go to [Add/Remove Programs](#) from the Control Panel. From the Install/Uninstall tab, scroll through the list of installed programs. Select Desktop Maid and push the Add/Remove... button. Follow the instructions on the screen to complete the uninstall process.

If Desktop Maid was installed using *Option 3*, load Explorer and navigate to the directory where it was installed. Delete the files installed from the archive. As a minimum, this should include **dtmaid.exe** and **DesktopMaid.hlp**.

Introduction

What is Desktop Maid?

Desktop Maid is a program for Windows 95 and NT that allows you to show or hide the icons found on your desktop. It also provides a quick access menu to your desktop items, making it easy to run items found on the desktop even when the item is hidden by another window. Desktop Maid is ideal for use during presentations, screen prints, and for low resolution monitors (i.e., 640x480, laptops, etc.).

Desktop Maid is a shareware program and comes with a free evaluation period. During this evaluation period, Desktop Maid will display a friendly message box each time you select an item from its menu. Registering Desktop Maid will prevent the message box from displaying.

In addition, registered users will receive the following benefits:

- FREE upgrades to all future versions of Desktop Maid.
- FREE technical support by e-mail and through WESoft Online.
- E-mail notifications of new releases as well as information on other West End Software products.

License Agreement

wesCommonLibrary is an Active X Automation server. It is intended to provide Microsoft Visual Basic 4.0 developers commonly needed functionality beyond that provided by Visual Basic for Applications (VBA).

wesError is an Active X Automation server. It provides application developers with a standard means of handling errors trapped in a procedure, either displaying the error or raising the error for trapping and handling in the calling procedure.

wesObjectCache is an Active X server. It is intended to provide application developers with a means of improving performance by caching Active X objects for reuse, particularly objects that must retrieve their properties from a database, file, remote data source such as a World Wide Web site, etc.

System Requirements

Desktop Maid runs under Windows 95 and Windows NT 4.0. The same version is compatible with both Windows 95 and NT 4.0.

Minimum System Requirements

-  Processor capable of running Windows 95, NT 4.0, or greater
-  500 KB Hard Drive space (1 MB for the installation process)
-  Windows 95, Windows NT 4.0, or greater
-  Mouse or some other pointer device

What is Shareware?

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.
