# 4T Pet Overview

**4T Pet** is a well-designed database application for tracking important Pet information. Each entry lets you enter a pet's name, date of birth, age, sex, weight, color, breed and other information including Veterinarian information and medical history plus and much more. User-customizable categories allow you to maintain multiple databases (i.e. one for each pet or species). Pull-down menus are utilized throughout to make data entry quick and simple. If you've ever had to find your Pet information fast, you'll certainly see the value of this easy-to-use application. Now you can keep all this information in the palm of your hand (no pun intended).

# Standard Features

- Export/Import to and from the Memopad for easy entry and backup
- 4T Pet remembers the status of your preferences settings.
- 4T Pet is designed for maximum navigation speed. Once the program is started, you can open an account with only 1 pen tap!!!
- Drop down labels allow the user to select from thousands of combinations of labels that best suit the account information.
- Cut, Copy, Paste, Undo, and Sort Items.
- Ability to categorize your accounts by pet name, species, breed or however you see necessary.
- Flag 'private' Items for added security with the built-in Palm Pilot security.
- User editable screen display, choose what you want to see.
- Hardware scrolling during Main Screen viewing.
- Create new records from a menu choice.
- System Info, displays number of records in database at any time.
- Delete records from menu shortcut.
- Get record details from menu shortcut
- Hardware button scrolls 1 page at a time.
- Choose to show number of records in database OR 4T Pet title on main screen.
- Remember last category, program starts in same category that it was exited in.

- Confirm on delete, choose whether to have the confirmation alert popup or not.
- Sort from a menu choice.
- Sort Ascending or Descending.
- Easy-to-use sort Icon on main screen.
- Find feature, similar to the Address find.

## Installing 4T Pet

### **New Installation.**

Install the included FPet.prc file by using the install application that is included with your Palm OS Desktop software.

# Usage

## Pet Items

The Main Form View is the 'home base' view of 4T Pet. The look and feel is very similar to the address list view of the Address application on the Palm Pilot. The accounts are listed in alphabetical order by the description field of the account.

## Creating a record

To create new record press the 'New' button from the Main Form View. The Item Details View screen will appear where you can start inputting your information, you can choose the label names by tapping on the drop down list of each label and selecting a new label. Enter the information in each field by tapping on the field to place the cursor and use the Graffiti input or Palm Pilot soft keyboard input to enter the record information. Use the drop down list box in the top right corner of the form to select a category for the Item that you are currently editing. Edit the list of categories by selecting 'Edit Categories...' from the category drop down list. Tap on the 'Private' check box to identify the account as private. This will allow you to utilize the built-in Palm Pilot security feature and hide the record until the Palm Pilot security password has been entered. Once finished, tap the 'Done' button and the Main Form View will appear.

## Viewing/Editing a record

To view/edit an record, select the account from the Main Form View by tapping on the name of the record. The Item Details View screen will appear with the record information. View or edit the information as needed and then tap the 'Done' button when finished viewing the account and the Main Form View will reappear.

## Deleting a record

To delete the record Item, tap on the Item, from the Main Form View, to bring up the Item Details View, then tap the delete "Trash Can" icon. A dialog box will prompt you to ensure that you don't accidentally delete the wrong record.

## Preferences:

### SHOW NUMBER OF RECORDS:

Choose to show number of records in database or 4T Pet title on main screen

### REMEMBER LAST CATEGORY:

Program starts in same category that it was exited in.

### CONFIRM RECORD DELETE:

Choose whether to have the confirmation alert popup or not.

# Export to Memopad

Exports data, in current category, to the memopad creating a new memo named "4TPet Export".

The structure for this exported memo is:

NOTE: The Date: field is not used, but may show up in the export.

NOTE: You can use one field or all fields. Only input the field and data that you need. Fields and lists without data will be ignored.

NOTE: The list fields ARE CASE SENSITIVE. They MUST be type in EXACTLY as they are in the program.

## Import from Memopad

Importing from the memopad is exactly the same as the export except for one thing, change the word Export to Import. The fields and the structure is exactly the same. As a matter of fact, the BEST way to insure no type-o's is to first export to memopad, then edit the data and import back into 4T Pet.

The minimum requirements are; 1.) new memo named "4TPet Import" 2.) First line of memo named "4TPet" 3.) ANY one of the fields below.

NOTE: The list fields ARE CASE SENSITIVE. They MUST be type in EXACTLY as they are in the program.
