



## **Total Uninstall**

Total Uninstall can help you to monitor any changes that were made to your system during installation of a new software product or any other computer activity that made changes in the file system and/or registry.

The program allow you to perform a complete uninstall without having to rely on the supplied uninstall program which may leave files or changes behind.

To use it, you simply launch the installation program from the Total Uninstall interface and select the system areas to be monitored. The program will then create a snapshot of your system before it installs the new software and an additional snapshot after install completes. It then compares the two snapshots and displays all changes in a graphical tree view, marking all values and/or files that have been added or changed as well as some before/after details. Total Uninstall will save these changes and if you decide to uninstall the application, it will reverse all changes to the previous state.

You can't uninstall applications already installed on your system or that are not monitored with this program.

**Hardware requirements**

Total Uninstall has minimal hardware requirements, It should work successfully on any hardware capable of running any 32-bit version of Windows.

**Software requirements**

Total Uninstall needs for running any version of 32-bit Windows. The program is self-contained and it does not need or depend to any system libraries, installed updates, patches etc. The program was tested on the following operating systems: Win 95, Win98, Win Me, WinNT, Win2000, WinXP.

I'd be thankful for reporting specifications of a system where Total Uninstall did not work correctly.

**Installation**

Extract all the files from the .zip package. Execute the Setup.exe program and follow the instructions. The Total Uninstall application file is called Tun.exe.

**Update**

Install the new version over the existing. The setup program will detect automatically the location of the previous version. If you uninstall the previous version, you will lose all program settings.

**How to Uninstall**

Uninstall Total Uninstall by using the Control Panel's Add/Remove Programs dialog box. Then remove manually the program folder that contains the \*.tun files, usually named "C:\Program Files\Total Uninstall".

### **1. Before scan - preinstall**

Total Uninstall creates a snapshot of your system (file system and registry) before the monitored application run. In the most of the cases monitored application is a setup utility but can be also any kind of application or other activity that make changes in the system. After this step the Total Uninstall application can be leaved active or can be closed.

### **2. Make changes - install**

Now you can launch the monitored application from Explorer or any file manager that you have or within the Total Uninstall interface.

### **3. After scan - post install**

Launch Total Uninstall if was closed or continue the wizard to record another snapshot, load the previous snapshot, compares the two, and show the differences in a graphical tree. The changes are saved automatically with the name provided in the first page of the wizard.

### **4. View and edit the changes**

Navigate in the Changes tree to see the detected changes.

The only operation you can make to alter the detected changes is removing the nodes from the tree. Delete the irrelevant detected changes like changes that you know that have nothing to do with the monitored application. After using the application several time you will become an expert when deciding what changes are irrelevant.

Save the changes made by you.

The folders added to this list will be skipped when scanning the file system (the chosen targets). If an excluded folder has several folders/files then the scanning/analyzing time and memory allocated during creation of the snap shoots is reduced.

The most suitable folders to be added to the ignore list:

- **"Recycle Bin"** - depending of your operating system this is for the C: drive "C:\RECYCLED" or "C:\RECYCLER"
- **Temporary Internet Files** - the folder where your browser store the internet cache.
- **Folders of the already installed applications** - some of them can run in background while monitoring so the changes made by these applications should be avoided to appear in the changes result. An example of such application is the mail client that you want always to run.
- **Folders with your data** - "My Documents" or other folders that you use to store important data.

Note:

You can add folders to the exclude folder list from Options dialog->Scanner tab or from Changes Tree view context menu.

The changes from these files will be ignored by the comparing algorithm. The files that appears in this list even if are deleted, created, changed or moved will not appear in the result.

There is no performance gain if you choose several files to ignore. If it is possible, exclude an entire folder instead of ignoring changes from all files from that folder.

Files that are suitable to be added in this list are:

- **SYSTEM.DAT** and **USER.DAT** - the files used by the Windows to store the registry
- **PAGEFILE.SYS** or **WIN386.SWP** - the Windows virtual memory file. The file name depend of the kind of operating system that you have.

Note:

You can add files to this ignore list using the Options dialog->Scanner tab or from Changes Tree view context menu.



The comparing algorithm will ignore the changes from registry key that appears in this list and also in their sub-keys and values.

Registry keys that are suitable to be added in this list are:

- **Known programs keys** located in the HKEY\_LOCAL\_MACHINE\Software\

- **Last known good hardware configuration** located in HKEY\_CURRENT\_CONFIG\System\CurrentControlSet. It is also recommended to ignore the backup of these hardware configurations located in HKEY\_CURRENT\_CONFIG\System\CurrentControlSet### where ## can be 00, 01, 02, ...

Note:

You can add files to this ignore list using the Options dialog -> Scanner page or from Changes Tree view context menu.

Start the Total Uninstall application. The "Install a new application" option is checked.  
Enter a friendly identifier for the monitored application. The identifier should be a valid file name.  
You can also drag and drop an executable over the current screen. The identifier is automatically filled.  
The changes detected during monitoring will be automatically saved in a file with the extension .tun  
and with the name the identifier that is given in this screen.  
Configure the scanner options. Most important are the Excluded folder List.  
Press the Next button to get the new screen.

- Choose the registry categories that you want to monitor. In the most of the cases is enough to monitor the following registry categories: HKEY\_LOCAL\_MACHINE, HKEY\_CLASSES\_ROOT, HKEY\_CURRENT\_USER

- Choose the folders to be scanned. The generic Program Files folder and the Windows folder are disabled and checked automatically if you want to scan the entire system partition. Usually is not necessary to scan the entire file system.

Using the Other folders field you can set additional folders to be scanned. Separate several paths by semicolon. The application will not check if the additional folders are duplicates so be sure that the same folder is not scanned twice.

If the operating system is Win2000 or WinXP then the "Documents and settings" folder should be added here as an additional folder.

The last targets combination will be restored the next time you use the application. Press next to allow Total Uninstall to create the pre-install snapshot.

In this screen you can choose between:

- **Install one application.** Type in the edit provided the application full path or use the right button to browse for the executable. You can also to drag and drop from Explorer the application that you want to start. The Total Uninstall will remember the last monitored application path. Pressing next the Total Uninstall will start the application to monitor. When the installation process is finished press next to allow Total Uninstall to create the post install snapshot.

- **Install several applications.** Choose this option if you intend to install more than one application or you don't want to keep Total Uninstall application in memory. Press exit to close the wizard. After the installations are completed you have to restart the Total Uninstall application to create the second snapshot and to search for the changes.

- **Install one or more applications during this screen.** Choose this option if you want to keep the Total Uninstall application active while you run the install program within Explorer or other file manager. You can minimize the Total Uninstall application until the installations are finished. When the installations are finished press next to allow Total Uninstall to create the post install snapshot.

Notes:










- Because most of the applications creates the registry entries, .ini files etc at first run is recommended to start the installed applications, make some specific operations and exit. Then you can continue to take the second snapshot.

- Many install utilities requires that you restart Windows to complete the process. Don't worry - Total Uninstall will close with Windows and will restart when the Windows is restarted. Then you can continue to take the second snapshot.






During this stage, Total Uninstall make the second snapshot, loads the preinstall snapshot and compares the pre and post-install snapshots. It shows the changes from system.

Detected changes after comparing the system snapshots:

#### Registry

-  created key
-  deleted key
-  new integer or binary value
-  deleted integer or binary value
-  modified integer or binary value
-  integer or binary shared file counter modified
-  new string value
- deleted string value
-  modified string value
-  string shared file counter modified

#### File System

- new folder
- deleted folder
-  new file
-  deleted file
-  modified file - date time stamp or size
-  file moved from this location(deleted)
-  file moved to this location(created)

You can delete the irrelevant nodes from the changes tree. Use the button to save your changes. The changes can be exported in a text file.

Start the Total Uninstall application.  
Configure the uninstaller options, decide what category changes to uninstall. Choose the log level.  
Choose the "Uninstall or view changes of a monitored application" option.  
Select from the below list a monitored application.  
Press the Next button to load the changes.

Changes that the Total Uninstall application can restore/uninstall has a checkbox in front:

#### Registry

- created keys will be deleted if don't have sub-keys
- deleted keys will be created
- ,
- created values will be deleted
- ,
- deleted values will be created
- ,
- modified values will be restored

#### File System

- created folders will be deleted if are not empty
- created files will be deleted

Uncheck the nodes from the tree that you don't want to be restored/uninstalled.

You can delete the irrelevant nodes from the changes tree. Use the button to save your changes.

The changes can be exported in a text file.

Press next to start uninstallation.



**It is recommended to uninstall the monitored applications in the reverse order.**

Because several applications can register the same file extension you can get an incorrect association with an already uninstalled application if you uninstall the monitored applications in a random order. Here is an example of such situation that can be avoided if the uninstallations are in the reverse order.

1. Windows clean install, .jpg files are registered to Internet Explorer
2. Installing application APP1 that register the .jpg extension
3. Installing application APP2 that re-register the .jpg extension
4. Uninstalling the APP1 will restore the .jpg extension association back to previous state, Internet Explorer. The .jpg extension is now registered with Internet Explorer.
5. Uninstalling the APP2 will restore the .jpg association to APP1 but this is already uninstalled->invalid association. In this case, you can avoid this situation if you choose to do not restore the registry values from the options dialog.

**Close the applications that will be uninstalled**

Because the Total Uninstall cannot delete files/folders that are in use (open) close the applications that will be uninstalled.

Use the operating system task manager or other utility to close the application/related processes to be uninstalled.

If Total Uninstall could not delete some files because they are still in use you should reboot the system and delete the files/folders manually.

**Delete manually the files/folder that Total Uninstall could not delete.**

Some files were created after the monitored process. These changes don't appear in the Total Uninstall log.

When uninstalling these files will not be deleted and also the folders that contains such files. In the uninstallation log will appear a line that the folder was not deleted because is not empty. Delete that folder manually if doesn't contain important data.

**Delete manually the non empty registry key that Total Uninstall didn't deleted**

As a precaution Total Uninstall didn't delete the registry key that contains sub-keys created after the monitoring process.

In the uninstallation log will appear a line that the registry key was not deleted because is not empty. You should decide if it is necessary to delete (manually) or not that registry key.

Total Uninstall is free for both commercial and non-commercial use. You are free to put the programs on a CD-ROM, but if you do so please send me a notification.

A Windows database that provides centralized storage of startup, configuration and other information. The registry stores information about all installed hardware and any software that has been designed expressly for the Windows operating system. The registry is organized into categories called "registry keys".

The registry stores its information in two binary files: SYSTEM.DAT, which maintains up-to-date computer-related data, and USER.DAT, which can maintain multiple system configurations for different users.

Shared DLLs are application libraries files (.dll, .ocx, \*.bpl, etc) containing functions that can be used by more than one application. So, more than one application can use in the same time, the same dll to run, preserving in this way the disk space and the RAM memory because the Windows loads a single instance of that dll that is shared between applications.

Is a common practice for each company that develops applications to have their own shared dlls.

The installer programs copy the shared dll usually in the Windows folder, Windows\System or in the Program Files\Common Files\<company> folders.

A DLL file is considered as shared if has associated a registry value (a counter) in the `HKEY_LOCAL_MACHINE\Software\Microsoft\Windows\CurrentVersion\SharedDLLs`. The name of the registry value is the DLL full path and the data is the number of applications that share that DLL.

When a uninstaller application uninstall an application that uses a DLL then should only decrement the DLL's counter. If the counter reach zero (theoretic no application depends by that DLL) the uninstaller program should remove the DLL file from the system and its counter.

Examples of common shared DLL are the Microsoft Visual Basic runtime libraries (`MSVBVMxx.DLL`) and Microsoft Foundation Class for Visual C (`MFCxx.DLL`).























**Install a new application**

Check this radio button if you want to monitor changes made by one application or more, or other system changes. To continue you must provide an identifier for the monitored application.

## **Identifier**

The identifier is a unique friendly name for the changes that will be detected and must be a valid file name.

This is used when saving/retrieving the detected changes.

You cannot continue without providing an identifier.



**Uninstall or view changes**

Check this radio button if you want to Uninstall/View/Edit / print changes. Before to continue you must select an identifier from the list.

**Options**

Configure the scanner and/or the uninstaller.

## **Identifiers list**

The list contains the identifiers of the previous monitored applications. These are available to uninstall / view / print. This list is filled from the Total Uninstall directory.

## **Overall progress bar**

Show the progress of the:

- Entire scanning, rescanning and comparing process
- Loading changes from file
- Uninstalling process

**Back**

Go back to previous step. In some situations, the previous step is not reachable so the button is disabled.

**Next**

Go to the next step. If the user must fill some information the button is disabled.

## **Exit / Stop**

You can abort any operation in progress if the button shows "Stop" or close the application if the button shows "Exit".

## **About**

Information's about application version and author.





## Changes tree

Detected changes after comparing the system snapshots (before and after running an application):

### Registry

- created key
- deleted key
- new integer or binary value
- deleted integer or binary value
- modified integer or binary value
- integer or binary shared file counter modified
- new string value
- deleted string value
- modified string value
- string shared file counter modified

### File System

- new folder
- deleted folder
-  new file
- deleted file
- modified file - date time stamp or size
-  file moved from this location(deleted)
- file moved to this location(created)

### **"Save" button**

Save the changes tree to disk. After monitoring an application the changes are automatically saved. This button is enabled only if the user made some changes in the tree (delete nodes).

## **"Print" button**

Print the changes tree. You can print the entire changes tree or only the selected branch.

### **"Export" button**

Export the changes tree to a text file. You can export the entire changes tree or only the selected branch.

**View binary as string**

View the binary registry values as string. The binary data that contains strings are made visible. The non-characters are replaced with dots.

**View binary as hexadecimal**

View the binary registry values as hexadecimal.

### **HKEY\_CLASSES\_ROOT registry category**

Windows store in this category the information's related to file associations, context menus visible in Explorer, OLE etc. This category is a shortcut to HKEY\_LOCAL\_MACHINEkey. When HKEY\_CLASSES\_ROOT and HKEY\_LOCAL\_MACHINE categories are both checked the Total Uninstall scanner will skip the registry key from HKEY\_LOCAL\_MACHINE that contains the same data like the entire HKEY\_CLASSES\_ROOT category. Is recommended to scan this registry category to be able to restore the changed file associations.

### **HKEY\_LOCAL\_MACHINE registry category**

Windows store in this category the information's about hardware settings, drivers, shared dll counters, uninstall information and other system settings. The installed applications can add here the configuration data.

Is recommended to scan this registry category.



### **HKEY\_USERS registry category**

Windows store in this category the information's about all users.  
Usually is not necessary to scan this category, is enough to monitor the HKEY\_CURRENT\_USER category.

### **HKEY\_CURRENT\_USER registry category**

Windows and installed software store in this category the settings specific for the current user (session).

Is highly recommended to scan this category.

### **HKEY\_CURRENT\_CONFIG registry category**

Windows store information's used by the GDI API (display, printers settings).  
Usually is not necessary to scan this category

**Scan "Windows" folder**

Windows generic folder. Is highly recommended to scan this target.

**Scan "Program Files" folder**

Generic Program files folder. Is recommended to scan this target.

Scan the entire system partition

Scan the entire logical partition where the Windows reside.  
It is recommended to scan this target only if you intend to install a trial application.

**Other folders**

Scan user defined folders.

**Other folders field**

Enter the folders that you want to be scanned. You can enter several paths separated by semicolon. These must be valid.



### **Installing one application**

Use this option if you want to launch the monitored application within the Total Uninstall interface.

**Application path**

Enter the application full path or search for the monitored application using the "Browse" button. You can also drag and drop and executable file from Explorer.

**"Browse" button**

Select the application (setup.exe) full path.

### **Installing several applications**

Choose this option if you want to monitor more than one application, launch the monitored application from Explorer or you don't want to keep running the Total Uninstall when installing.

**Monitored application is started**

Choose this option if the monitored application is started by you after the first scanning stage has finished.

## **Uninstall log**

Show the errors, warnings or all actions during the un-installation process. Try to find the cause and make these actions manually.  
Configure the un-installation log level from options dialog.

**Ok button**

Save and apply the changes. Close the dialog.

**Cancel button**

Close the dialog without saving the changes.



### **Changes tree font**

Select the font that will be used to display the changes tree. The same font is used when printing.

### **Changes tree font size**

Select the font size that will be used to display the changes tree. The same font size is used when printing.

**Viewer**

Enter the program exe name to be used to view files when right clicking on changes tree and select "View".

## **Language**

The list with available(installed) translations for this application.

### **Exclude folders from scanning**

The scanner will skip the content of the folders from this list. Using context menu from Changes tree can be added entries in this list.

**Add folder**

Open a browse dialog where you can select or enter a path to be added to "Exclude folders list".

**Remove folder**

Remove the selected folder from "Exclude folders list".

### **Ignore changes from files**

The files from this list will not be added to the Changes tree. Using context menu from Changes tree can be added entries in this list



**Add file**

Show an open dialog where you can select a file name to be added to the ignore file list.

**Remove file**

Remove the selected file from "Ignore files list".

### **Ignore changes from registry keys**

The changes from the registry keys will not be added to the Changes tree if the key is in this list. Using context menu from Changes tree can be added entries in this list.

### **Add registry key**

Show a dialog where you can type a registry key path name to be added to the ignore list.

**Remove registry key**

Remove the selected registry key from the ignore list.

### **Delete created values**

If checked, when uninstalling, the created registry values ,  
 detected during monitoring process will be deleted. You can still choose to do not delete some values in the changes tree unchecking the checkbox in front of each change.  
If you uncheck this option then the created registry values from the changes tree will not have the checkboxes in front.

### **Create deleted values**

If checked, when uninstalling, the deleted registry values ,  
 detected during monitoring process will be created.

You can still choose to do not create some values in the changes tree unchecking the checkbox in front of each change.

If you uncheck this option then the deleted registry values from the changes tree will not have the checkboxes in front.

**Restore changes values**

If checked, when uninstalling the registry changed values will be restored.



**Delete created keys**

If checked, when uninstalling the created registry keys will be deleted, except the case when has sub-keys.

**Create deleted keys**

If checked, the deleted registry keys will be created.

### **Decrease shared dll's counter**

If checked, the counters of the shared DLLs ,

will be decremented with the amount that was incremented during monitoring process. The counters can reach zero or can become negative.

**Delete created files**

If checked, the detected created files will be deleted. If a shared dll has the counter zero or less this will be deleted to Recycle Bin.  
You can choose to use the Recycle Bin or not only for ordinary files (no shared DLLs).

## **Use Recycle Bin**

Delete the files to Recycle Bin.

### **Delete created folders**

Delete created folders. If the folders still have files/folders after deleting the created files then they will not be deleted.

## **Background image**

Show the background image in the changes tree
