

GcMail License

This license applies to the licensed version of GcMail.

Your Agreement to this License

This License only applies to the English-language version of the GcMail software and its accompanying files, data and materials. You should carefully read the following terms and conditions before using, installing, copying, or distributing this software. Unless you have a different license agreement signed by GeveSoft, your use, installation, copying, or distribution of GcMail indicates your acceptance of this agreement ("License").

If you do not agree to all of the terms and conditions of this License, then: (a) do not use, install, copy, or distribute any copy of GcMail with which this License is included, and (b) in addition, if you paid GeveSoft or an authorized GeveSoft reseller for a package consisting of one or more copies of GcMail, you may return the complete package unused, within thirty (60) days after purchase, for a full refund of the license fee.

The terms and conditions of this License describe the permitted use and user(s) of each Licensed Copy of GcMail. For purposes of this License, if you have a valid single-copy license, you have the right to use a single "Licensed Copy" of GcMail; if you or your organization have/has a valid multi-user license, then you or your organization have/has the right to use up to a number of "Licensed Copies" of GcMail equal to the number of copies indicated in the documents issued by GeveSoft when granting the license.
