License agreement

This End User License Agreement accompanies the LeechGet product and related explanatory materials ("Software"). The term "Software" also shall include any upgrades, modified versions or updates of the Software licensed to you by the LeechGet Team. Please read this Agreement carefully. At the end, you will be asked to accept this agreement and continue to install or, if you do not wish to accept this Agreement, to decline this agreement, in which case you will not be able to use the Software. Upon your acceptance of this Agreement, we grant to you a nonexclusive license to use the Software, provided that you agree to the following:

1. Use of the Software

You may install the Software on a hard disk or other storage device; install and use the Software on a file server for use on a network for the purposes of (i) permanent installation onto hard disks or other storage devices or (ii) use of the Software over such network; and make backup copies of the Software. You may make and distribute unlimited copies of the Software, as long as each copy that you make and distribute contains this Agreement, the LeechGet installer, and the same copyright and other proprietary notices pertaining to this Software that appear in the Software. If you download the Software from the Internet or similar on-line source, you must include this copyright notice for the Software with any on-line distribution and on any media you distribute that includes the Software.

You may use the LeechGet Personal Edition (that means non-licensed version) on an unlimited amount of computers for strictly non-commercial purposes. "Non-commercial" is defined as usage in any individual, educational institution, charity or humanitarian organization. Commercial purpose is defined as usage in any corporation registered or otherwise that derives or attempts to derive substantial commercial and monetary gain and benefit from its efforts and endeavours. This includes all Government and Military entities. You have to acquire a license key if you plan to use LeechGet for commercial purposes as defined above. The licensed version of LeechGet is called LeechGet Premium.

When you purchase a license you will be provided with a license key. You should enter the license key as prompted by the Software. The licensed Software may be used by the number of users indicated in your license key and on our invoice. If the Software is installed on a terminal/network server or other storage device, you must purchase a license for each user who uses the Software. A license for the Software may not be shared by alternating use of the Software between different users. For each user a license has been purchased can make and use one copy of the Software on his or her portable computer. You may also make one copy of the Software for back-up or archival purposes. Otherwise, you may not copy the Software in whole or in part. You may permanently transfer all of your rights under this license provided you transfer all copies of the Software and the recipient agrees to the terms of this license.

An owner of a license has time-unlimited right to use, upgrade and update the Software. This applies for all Software versions with major version numbers 0.xx and 1.xx.

2. Copyright and Trademark Rights

The Software is owned by Martin Albiez (the author) and his team, and its structure, organization and code are the valuable trade secrets of the LeechGet Team. The Software also is protected by German and European Copyright Law and International Treaty provisions. You may use trademarks only insofar as required to comply with Section 1 of this Agreement and to identify printed output produced by the Software, in accordance with accepted trademark practice, including identification of trademark owner's name. Such use of any trademark does not give you any rights of ownership in that trademark. Except as stated above, this Agreement does not grant you any intellectual property rights in the Software.

3. Restrictions

You may not reverse engineer, de-compile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation. You may not rent, lease, or lend the Software. You may permanently transfer all of your rights under this EULA, provided the recipient agrees to the terms of this EULA. You may not use the Software to perform any unauthorized transfer of information (e.g. transfer of files in violation of a copyright) or for any illegal purpose.

4. No Warranty

The Software is being delivered to you AS IS and the author and his team make no warranty as to its use or performance. THE LEECHGET TEAM DOES NOT AND CANNOT WARRANT THE PERFORMANCE OR RESULTS YOU MAY OBTAIN BY USING THE SOFTWARE OR DOCUMENTATION. THE LEECHGET TEAM MAKES NO WARRANTIES, EXPRESS OR IMPLIED, AS TO NONINFRINGEMENT OF THIRD PARTY RIGHTS, MERCHANTABILITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. If any part of this Agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. You agree that the Software will not be shipped, transferred or exported into any country or used in any manner prohibited by any export laws, restrictions or regulations. This Agreement shall automatically terminate upon failure by you to comply with its terms. This Agreement may only be modified in writing signed by an authorized member of the LeechGet Developer Team.
