

Apple Computer, Inc. Software Licence

PLEASE READ THIS SOFTWARE LICENCE AGREEMENT "LICENCE" CAREFULLY BEFORE USING THE SOFTWARE. BY USING THE SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENCE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENCE, PROMPTLY RETURN THE SOFTWARE TO THE PLACE WHERE YOU OBTAINED IT FOR A REFUND.

1. Licence. The software and any fonts accompanying this Licence whether on disk, in read only memory, or on any other media (the "Apple Software") are licensed, not sold, to you by Apple Computer, Inc. or its local subsidiary, if any ("Apple"). You own the media on which the Apple Software is recorded but Apple and/or Apple's licensor(s) retain title to the Apple Software.
