

# Terran Interactive, Inc. Software License

IMPORTANT - BY INSTALLING THIS SOFTWARE, YOU AGREE TO BECOME BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT INSTALL THE SOFTWARE.

The computer program ("software") is licensed, not sold, to you by Terran Interactive for use only under the terms of this License, and Terran Interactive reserves any rights not expressly granted to you. You own the disk(s) on which the software is recorded, but Terran Interactive and its licensors retain ownership of the software itself. You are responsible for installation, management, and operation of the software.

## License

This license allows you to:

- 1.) Use one copy of the software on a single computer at a time. To "use" the software means that the software is either loaded into the memory (RAM) of a computer or installed on the permanent memory of the computer (hard-drive, etc.).
