A. UPGRADING

Upgrading from V6.x

Simply install the new version in the same folder your existing version is installed in. Setup will update the necessary files.

If you choose to uninstall your exisiting version before installing the new version (using the Add/Remove Programs Applet in Control Panel or the uninstall icon) the first time you run the new version you will need to cancel the *Create New Diary* dialog and choose *Browse* on the login screen to select your diary file. The uninstall process will **NOT** erase any files that were created by you (ie. your diary entries and organizer information).

DO NOT use the Diary Conversion Wizard. Diaries created with V6.x are completely compatible with this version.

Upgrading from V4.x or V5.x

DO NOT uninstall your exsiting copy of My Personal Diary because it will remove all your configuration settings and you should have these to run the *Diary Conversion Wizard* described below. Simply install the new version to the same directory that you have your previous copy installed in. Setup will update the necessary files automatically.

My Personal Diary now stores all entries in a single encrypted, compressed file. If you have an exsiting diary created with a previous version you must use the *Diary Conversion Wizard* (DCW) to import your diary. The DCW is installed with MPD and takes your existing entries and copies them into a new diary file in the new format.

When the DCW asks for your old password make sure you enter it **EXACTLY** as you did for your existing diary. If you mistype the password and you have uninstalled your old version the DCW will have no way of verifying the password and will assume that it is correct. In this case your entries will not be converted correctly (the text in them will be scrambled) and you will have to repeat the conversion with the correct password.
